# Mahindra Auto records highest ever SUV sales of 43,708 vehicles, a 36% growth and highest ever total volumes of 80,679 in October 2023

**Mumbai, November 01, 2023:** Mahindra & Mahindra Ltd. (M&M Ltd.), one of India's leading automotive companies, today announced that its overall auto sales for the month of October 2023 stood at **80,679** vehicles, a growth of 32%, including exports.

In the Utility Vehicles segment, Mahindra recorded the highest sales for the fourth consecutive month. In October, the company sold **43,708** vehicles in the domestic market, a growth of 36% and overall, **44,264** vehicles, including exports. The domestic sales for Commercial Vehicles stood at **25,715** units, also the highest-ever.

According to Veejay Nakra, President, Automotive Division, M&M Ltd., "In October, we clocked the highest ever volumes at 80,679 vehicles, a growth of 32%. Both SUVs and CVs individually achieved highest ever volumes for the third consecutive month at 43,708 and 25,715 vehicles respectively. While the strong festive demand should see us continue our growth momentum in November, we will keep a close watch of select supply related challenges."

## Mahindra's Farm Equipment Sector Sells 49,336 Units in India during October 2023

**Mumbai, November 01, 2023:** Mahindra & Mahindra Ltd.'s Farm Equipment Sector (FES), part of the Mahindra Group, today announced its tractor sales numbers for October 2023.

Domestic sales in October 2023 were at **49,336** units, as against **50,539** units during October 2022.

Total tractor sales (Domestic + Exports) during October 2023 were at **50,460** units, as against **51,994** units for the same period last year. Exports for the month stood at **1,124** units.

Commenting on the performance, **Hemant Sikka, President – Farm Equipment Sector, Mahindra & Mahindra Ltd.** said "We have sold 49,336 tractors in the domestic market during October 2023. Higher aggregate kharif production, higher MSP for key Rabi crops and government's continued support to the agri economy in H2 of this year, are leading to positive sentiments among farmers during the on-going festive season, supporting tractor demand. In the exports market, we have sold 1,124 tractors."
