Mahindra Auto records highest ever SUV sales of 71624 vehicles, a 31% growth and highest ever total volumes of 120142 in October 2025

Mumbai, November 01, 2025: Mahindra & Mahindra Ltd. (M&M Ltd.), one of India's leading automotive companies, today announced that its overall auto sales for the month of October 2025 stood at **120,142** vehicles, a growth of **26%** including exports.

In the Utility Vehicles segment, Mahindra sold **71624** vehicles in the domestic market, a growth of **31%** and overall, **73890** vehicles, including exports. The domestic sales for Commercial Vehicles stood at **31741**, a growth of **14%**.

According to **Nalinikanth Gollagunta, CEO, Automotive Division, M&M Ltd.**, "In October, we achieved SUV sales of 71,624 units, a growth of 31%, which is the highest SUV sales we have clocked ever in a month! The total vehicle sales stand at 120,142 units, a 26% growth compared to the same month last year. October also saw the launch of the new editions of Thar, Bolero & Bolero Neo."

Mahindra Farm Equipment Business Sells 72,071 Tractors in India during October 2025, registering a growth of 12%

Mumbai, November 01, 2025: Mahindra & Mahindra Ltd.'s Farm Equipment Business (FEB), part of the Mahindra Group, today announced its tractor sales numbers for October 2025.

Domestic sales in October 2025 were at **72,071 units**, as against **64,326** units in October 2024, reflecting a **12%** year-on-year growth. For the festive period of September & October 2025 put together the growth is **27.4%** compared with same period last year, on account of split of festive season in these 2 months in 2025 compared to full festive season falling in October last year.

Total tractor sales (Domestic + Exports) during October 2025 were at **73,660** units, as against **65,453** units for the same period last year. Exports for the month stood at **1,589** units which was a growth of **41%**.

Commenting on the performance, **Veejay Nakra, President – Farm Equipment Business, Mahindra & Mahindra Ltd.** said, *"We have sold 72,071 tractors in the domestic market during October, a growth of 12% over last year. For the festive period of September & October 2025 put together the growth is 27.4% over same period last year. A good monsoon, combined with the benefit of GST rate cut announced in September have supported the strong performance in September & October 2025. Going forward, factors like timely onset of Rabi sowing & good progress in Kharif harvesting augur well for tractor sales."*
