Mahindra Auto clocks 60,272 SUVs and 99,969 total vehicle sales in March 2026

Mumbai, April 01, 2026: Mahindra & Mahindra Ltd. (M&M Ltd.), one of India's leading automotive companies, today announced that its overall auto sales for the month of March 2026 stood at **99,969** vehicles, a growth of **21%** including exports.

In the Utility Vehicles segment, Mahindra sold **60,272** vehicles in the domestic market, a growth of **25%** and overall, **62,109** vehicles, including exports. The domestic sales for Commercial Vehicles stood at **24,928**, a growth of **11%**.

The financial year concluded with all-time-high volumes of **6,60,276** SUVs and **2,89,597** LCVs (<3.5T), delivering robust YoY growth of **20%** and **13%**, respectively, across both segments.

According to **Nalinikanth Gollagunta, CEO, Automotive Division, M&M Ltd.**, "The Financial year ended on a very positive note, with Mahindra clocking its highest-ever volumes in both SUVs & LCVs (<3.5T) segments, a significant milestone for the company. In March, we achieved SUV sales of 60,272 units, a growth of 25% and LCV <3.5T sales of 24,928 units, a growth of 11% YoY. Total vehicle sales stood at 99,969 units, a 21% YoY growth"

Mahindra Farm Equipment Business sells 43,403 Tractors in March 2026 registering a growth of 33%

Registers highest ever annual domestic sales of 5,05,930 in FY26, with 24% growth

Mumbai, April 01, 2026: Mahindra & Mahindra Ltd.'s Farm Equipment Business (FEB), part of the Mahindra Group, today announced its tractor sales numbers for March 2026.

Domestic sales in March 2026 were at **43,403** units, as against **32,582** units in March 2025, reflecting a **33%** year-on-year growth.

Total tractor sales (Domestic + Exports) during March 2026 were at **45,035** units, as against **34,934** units for the same period last year. Exports for the month stood at **1632 units**.

Commenting on the performance, **Veejay Nakra, President – Farm Equipment Business, Mahindra & Mahindra Ltd.** said *“We have sold 43,403 tractors in the domestic market during March 2026 registering a robust growth of 33% over last year. A significant part of this high growth was driven by the full Navratri season falling entirely in March’26, unlike last year when it was split between March and April. We ended FY26 with highest ever sales of 5,05,930 registering growth of 24%. In the exports market, we have sold 1632 tractors.”*

Mahindra’s Trucks & Buses Business sells 4267 vehicles in March 2026 registering a growth of 13%

Mumbai, April 1, 2026: Mahindra & Mahindra Ltd. (M&M Ltd.), today announced that its overall sales including exports in the Trucks and Buses business (CV > 3.5T) for the month of March 2026 stood at 4267 vehicles, a y-o-y growth of 13%.

Mahindra’s Trucks & Buses business comprises of Mahindra Trucks & Buses division (MTBD) and SML Mahindra Limited (SML).

According to **Vinod Sahay, Executive Chairman – SML, President – Aerospace, Defence, Trucks, Buses & CE, M&M**, “Despite the headwinds faced from global geopolitical tensions and elevated crude prices, the commercial vehicle industry has sustained its strong momentum, underscoring the sector’s resilience. Looking ahead, the trajectory for F27 remains mixed - while replacement demand and government-led projects are expected to support volumes, volatility in fuel costs and supply chain constraints could temper sentiment.”
